- The term of the Chairperson and Members shall be for a period of two years.
- The term of the Special Invitee shall be one year.
- The quorum for the meeting including the Chairperson, but excluding the Special Invitee, shall be three.
- In considering the grievances before it, the USGRC shall follow principles of natural justice.
- The USGRC shall send its report with recommendations, if any, to the competent
  authority of the institution concerned and a copy thereof to the aggrieved student,
  preferably within a period of 15 working days from the date of receipt of the complaint.
- Any student aggrieved by the decision of the Students' Grievance Redressal Committee
  may prefer an appeal to the Ombudsperson for Somaiya Vidyavihar University Shri.
  Bharat Vyas, Retd. District and Additional Sessions Judge, Nagpur, within a period of
  fifteen days from the date of receipt of such decision.
